“Participating HP Reseller” is a reseller authorized by the Promoter to sell the Eligible Products in Australia who has agreed to participate in this promotion. “Participant” means a resident of, or business trading in, Australia who purchases and Eligible Product from a Participating HP Reseller or HP Direct during the Promotional Period and is the End User of that Product.
