



HP OMEN MAX 16 Cashback
26 February 2025 – 13 April 2025
Terms and Conditions – HP Australia

Definitions:

“Eligible Product” means any of the following HP OMEN MAX 16 originating from the Promoter, which is set out in the table contained in the appendix.

“HP Direct” is a direct sales agreement between the End User and Promoter including via the HP Online store in Australia.

“Participant” means a resident of, or business trading in, Australia who purchases an Eligible Product from a Participating Partner in Australia during the Promotional Period and is the End User of that Eligible Product. The Promoter, its related bodies corporate, resellers of HP products and any agencies associated with this Promotion their employees and those employees’ immediate families are ineligible to participate.

“End User” is a Participant who purchases an Eligible Product for his, her or its own personal use in Australia and not for resale or re-supply or export.

“Promoter” means HP PPS Australia Pty Ltd (ABN 16 603 480 628), of Rhodes Corporate Park, Building F, 1 Homebush Bay Drive, Rhodes, NSW 2138.

“Participating Partner” means a reseller authorized by the Promoter to sell the Eligible Products in Australia who has agreed to participate in this promotion, including:

The "Promotional Period" commences on 12AM AEDT 26 February 2025 and closes at 11.59PM AEDT 13 April 2025 (inclusive) whereby the purchase of the Eligible Product by the Participant must occur within this period.

"Reward" is as specified below: Cashback reward corresponding to the relevant Eligible Product in the Table above which will be delivered to each successful Participant via electronic funds transfer. There is a limit of three (3) entry redemptions for each Participant.

Information on how to enter this Promotion and redemption details form part of these terms and conditions. By submitting an entry, Participant agrees to these terms and conditions.

1. Entry is only open to a Participant. The Promoter reserves the right to verify the validity of each entry, including whether the entrant qualifies as a "Participant". The Promoter reserves the right to disqualify any Participant or person tampering with the entry process or any entrant who does not meet the eligibility requirements or does not comply with these terms and conditions. The corresponding tax invoice submitted must contain the following:

 - iii. Participating Partner's company name
 - iv. Participating Partner's company Business Number
 - v. sale purchase date
 - vi. sale purchase price
 - vii. list of eligible products sold
 - viii. invoice number
3. The Participant must correctly and fully complete an official online claim form at: www.hp.com.au/gamingpromo with all required information by 11.59PM AEDT 13 May 2025. Handwritten tax invoices and delivery dockets will not be accepted as proof of purchase. Any claim form submitted without the required proof of purchase documentation will be rejected. The Promoter may conduct audit calls to End-User Participants to verify that the Eligible Product was purchased during the Promotional Period and has not been returned. If an Eligible Product is returned, the Promoter reserves the right to take back any Rewards provided as part of the claim.
 4. If the Reward claim meets the Promotion terms and conditions, the Participant will receive a claim approval email to the email address that was nominated by the Participant.
 5. All entries must be submitted online by 11.59PM AEDT 13 May 2025 ("Closing Date"). Participant(s) will forfeit submissions not made by this date.

12. Claims are not transferable or assignable. Only the Participant who purchased an Eligible Product may submit a claim.
13. Once claims have been received and verified please allow up to approximately 75 days for receipt of reward.
14. The Promoter does not accept any responsibility for misleading or incorrect information provided by a Participating Partner regarding this Promotion.
15. Liability for any tax on any rewards provided to Participants pursuant to this Promotion shall be the sole responsibility of the Participant. It is recommended that Participants should contact their own accountant or taxation advisor in this regard.
