



## HP Monitor Gaming Promotion Terms & Conditions

### Definitions

1. "Eligible Product" means each of the HP-branded produces listed in the column "Eligible Products" in the table below.

"End-User" is a Participant who purchases any Eligible Products from a Participating HP Reseller or HP Direct for use in Australia and not for resale, re-supply or export.

"HP Direct" is a direct sales arrangement between the End User and Promoter including via the HP Online Store in Australia.

"Participating HP Reseller" is a reseller authorized by the Promoter to sell the Eligible Products in Australia who has agreed to participate in this promotion.

"Participant" means a resident of, or business trading in, Australia who purchases an Eligible Product from a Participating HP Reseller or HP Direct during the Promotional Period and is the End User of that Product. The Promoter, its related bodies corporate, resellers of HP products and any agencies associated with this Promotion, their employees and those employees' immediate families are ineligible to participate.

- iii. Sale purchase date
- iv. Sale purchase price
- v. List of Eligible Products sold
- vi. Invoice number

Hand written tax invoices and delivery dockets will not be accepted as proof of purchase. Any claim form submitted without the required proof of purchase documentation will be rejected.
