



Terms & Conditions

1. Subject to the remainder of these terms and conditions customers purchasing one of the Qualifying HP Products can claim a defined cashback amount. This cashback offer is valid only for purchases made during the respective promotional periods for the Qualifying HP Products as detailed in the table below (section 29: Qualifying HP Products and respective promotional periods), specified cashback amounts will not be granted if the particular Qualifying HP Product is purchased outside the respective promotional period.
 2. Customers may claim cashback for a maximum of 5 Qualifying Products.
 3. To take advantage of the promotion, customers must complete the online claim form (available at "hp.com/uk/savemoney").
