You may review, save or print any part of these Terms. We encourage you to print out a copy of this entire document and refer to it as you benefit from the one-year bonus HP warranty promotion.

## 1. Object

1.1. This one-year bonus HP warranty is obtained through: (1) registration of your Eligible HP product (as this term is defined below) at [www.hp.com/eu/bonuswarranty/](http://www.hp.com/eu/bonuswarranty/) within 60 days of Eligible HP product purchase; and (2) acceptance of these Terms.

1.2. HP offers you an up to 3 years HP Warranty (i.e. commercial warranty) for Eligible HP products consisting of: (1) 1 year standard HP Warranty; (2) 1 extra year if you activate HP+ at setup; and (3) 1 bonus year through registration. If you activate HP+ at setup but do not register for the 1-year bonus HP Warranty or vice-versa (i.e. you register but do not activate HP+), the total HP warranty duration will be 2yrs. If you decide to neither activate HP+ nor register for the 1-year bonus HP Warranty, the HP warranty total duration will be of 1year.

1.3. The HP warranty including extensions are subject to the HP Limited Warranty Statement provided with your Eligible HP product (as this term is defined below). You can also consult HP Limited Warranty Statement [here](#). In case of contradiction between the HP Limited Warranty Statement provided with your Eligible HP product and the one available online in the link above, the one provided with your Eligible HP product will prevail.

1.4. If you are a consumer, the HP Commercial Warranty benefits do not replace or limit any statutory rights provided under consumer protection laws related to nonconforming of goods with the contract of sales. Consequently, HP Commercial Warranty is independent, complementary to and does not affect in any way the said statutory rights.
